VSC Inc. Policies Which Will Be Enforced

1. If less than 20 cars are registered at the close of nominations, then a minimum of 12 nominations must be received, with 12 nominations on race day to constitute a State Title.

If more than 20 cars are registered at close of nominations, then a minimum of 15 nominations must be received, with 15 confirmed nominations on race day to constitute a State Title.

Exception Ladies and Junior classes, which require a minimum of 12 nominations received and 12 nominations confirmed on race day to constitute a State Title.

2. If necessary, the VSC will allocate a roof number as close as possible to the cars' actual number, in the event of 2 cars nominating with the same number. Preference will go firstly to the home track car, then as nominations are received.
3. All other requirements as per State policy and the VSC Inc. Racing Rules & Regulation Manual
4. Nomination fee of \$90 per entry, including transponder fee (if transponder not required fee is \$60 transponder number to be entered on nomination form). Late nominations will be required to pay non-refundable fee of \$150 inclusive of transponder (if transponder not required fee is \$120 and transponder number to be supplied by you prior to racing).
